- ☐ I understand that any later restoration or reacquisition of Fortressian citizenship requires a separate application and is not automatic.
- ☐ I agree to surrender, cease using, or permit cancellation of Fortressian citizenship documents and credentials as directed after renunciation becomes effective.
- ☐ I understand that this application concerns only the applicant named above and does not by itself alter the citizenship of any spouse, child, dependent, or other person.
- ☐ I certify that the information and documents submitted are true, complete, and not intended to evade any lawful obligation or proceeding.
