

PRINCIPALITY OF THE PILLOW FORTRESS

NOTIFICATION OF BIRTH AND REQUEST TO RECORD CHILD CITIZENSHIP

Submit the completed form and required evidence to the Department of Population

Purpose. Use this form to notify the Principality that a child has been born to at least one Fortressian citizen and to request that the child's citizenship be examined and entered in the citizenship register. This form is not a birth certificate, does not replace registration required by the jurisdiction where the birth occurred, and does not itself establish citizenship until accepted by the Department of Population.

INSTRUCTIONS AND REQUIRED ENCLOSURES

Enclose a certified copy of the child's civil birth certificate, official birth-register extract, or other government record establishing live birth, the child's date and place of birth, and parentage. If no ordinary civil birth record is reasonably available, enclose the best available evidence of live birth, such as a hospital or clinical record, a declaration by the attending physician or midwife, an official local notification of live birth, sworn witness statements, or other evidence accepted by the Department. Also enclose evidence of the Fortressian citizenship of each parent through whom citizenship is claimed. Documents not in a language accepted by the Department should be accompanied by a complete certified translation. Do not send irreplaceable originals unless specifically instructed.
